





OUR MISSION





INTERIM GUIDANCE 13 NOVEMBER 2020





- Our PPE meet or exceed the technical specifications outlined by the World Health Organization (WHO) to keep Canadians safe. We follow the WHO's guidance on quality, performance characteristics and related standards for personal protective equipment (PPE) to be used for COVID-19.
- This includes WHO Priority Medical Devices, specifically: surgical masks, non-surgical masks, gloves, goggles, face shields, gowns and N95 masks and other equipment.
